It receives a large number of tributaries both from the left as well as from the right. But the left bank tributaries are more in number and large in size than the right bank tributaries. The Manjra (724 km) is the only important right bank tributary. The Penganga, the Wardha, the Wainganga, the Indravati and the Sabari are important left bank tributaries.
